### A Message from Our President

It was a cold winter's night, but that did not stop the hearty souls of the Beacon Sloop Club who turned out for the general meeting Friday evening. The food was plentiful and good. The meeting started with a couple of rousing songs.

This is a good time to relax and review the past and look toward the future. The last year was a good year. We renovated much of the building and it withstood the flood. (Kudos to the Building committee, Aaron Havens, and all those who contributed time.) We still need to repair the last remaining section of the old diner. This will be done as soon as the weather warms enough to work without freezing. Thanks to volunteers we have a plentiful supply of wood for the winter.

The Woody completed another year of providing over a thousand people with the experience of sailing on the Hudson in an old wooden sloop. Our winter series of talks was well attended and we did well with all our festivals. The board has made the decision to hold all of our 2013 festivals in Riverside Park. We have more room to expand and grow. But this also means we need to make more food to sell as well sold all the pies, chili and soup at the Pumpkin Festival in 2 1/2 hours.

This year our major goal will be to raise money to repair the Woody Guthrie. We need between \$150,000 and \$175,000. We still need to raise between \$80,000 and \$100,000. We will be actively looking for some matching grants as well as sponsoring smaller monthly events, concerts, dances, wine or beer tasting's, etc. We raised \$800 at the holiday Fundraiser. I want to thank Chris Ruhe and the Howlin' Wolves and Judith Tullock and her band. If you have an idea for a fundraiser let us know.

We kept the same officers for the new year except for Secretary. James Malchow is our new secretary. Vane Lashua is now membership committee chairman, a vitally important position. We will be working on plans to increase and retain membership over the coming year.

I wish to thank all those who volunteered this last year. You are the Heart and Soul of this Club. We celebrate you.

## Beacon Sloop Club General Meeting Minutes, January 4, 2013

The meeting began at 7:30 with musicians singing John Lennon's "Imagine" and "This Little Light of Mine."

President David Eberle welcomed newcomers to the club from Israel, Taiwan, and Argentina.

**Treasury:** Sarah Elisabeth reported that the club's closing balance for 2012 was \$71,446.00, with \$1,900 spent in October. David added that the club will need another \$80,000 for the Woody restoration.

David Eberle reported that there is a new matching grant for the Woody restoration.

**Membership:** David announced that this was the time of year when most people need to renew their membership.

**Woody Maintenance:** It was reported that the Block Party will be held sometime in February and that more details will be announced.

**Woody Dinner:** Alan Thomas (for Tom LaBarr) announced that the Woody Dinner will be held on February 23rd, though the location is not yet certain. The cost will be \$50 per person. There will be lots of door prizes, last year it was roughly one door prize for each two people in attendance.

**Building Committee:** Saul Rozinsky reported that the wall behind the wood stove will be rebuilt entirely. It is the last remaining wall from the old ferry diner but is rotted on the bottom. Work will begin when the weather is less frigid.

**Environmental Lectures:** Alan Thomas announced that the first lecture in the club's annual lecture series will be held on January 18th, 2013 and will be on the subject of "Alternative Energy Solutions". There will be three speakers, Christina Bagen, Saul Rozinsky, and Vane Lashua, speaking on "Solar 101," "Simple Solar," and "Deep Geothermal." The lectures are free for the public and held at the Sloop Club. They are held every 3rd Friday from January through May.

**Summary of Clearwater's Environmental  
 Justice Contention Testimony at Indian Point  
 Relicensing Hearings in front of the Atomic  
 Safety Licensing Board October 23, 2012. –  
 Manna Jo Greene**

**Clearwater's Contention:** Clearwater asserted that neither Entergy's Environmental Report (ER) nor the Final Supplemental Environmental Impact Statement (FSEIS) prepared by the Nuclear Regulatory Commission (NRC) Staff analyze the disproportionate impact that a nuclear release at Indian Point would have on environmental justice populations (low income, minority, disabled, infirmed) and do not adequately discuss any mitigation that that would limit exposure

At hearing before the Atomic Safety Licensing Board (ASLB) panel of judges, the NRC Staff acknowledged they did not take into account potential disparate impact on elderly, disabled, mobility impaired and prison populations in the event of a radiological release in their environmental impact statement. Also, in considering the Environmental Justice (EJ) impacts if there is a relicensing, NRC did not do an analysis of disproportionate impacts of a severe accident, because they viewed the risk of accident as small and they viewed it as outside the scope of their guidance.

**Clearwater Witnesses:** Armed with four volumes of pre-filed testimony, nine witnesses presented Clearwater's case: **Dr. Michael Edelstein**, an Environmental Psychologist and professor at Ramapo College, **Anthony Papa**, a former inmate, who, under the Rockefeller drug laws, served twelve years of a 15-to-life sentence in Sing Sing prison, **Dr. Erik A. Larsen**, Director of Emergency Medicine at White Plains Hospital, **Dr. Andrew Kanter, Dolores Guardado**, a Peekskill resident and native Spanish speaker, **Aaron Mair**, an expert on Environmental Justice, **John Simms**, a resident of an assisted living community in Cortlandt, **Stephen Filler**, an attorney and Clearwater Board member, and **Manna Jo Greene**, Clearwater Environmental Director.

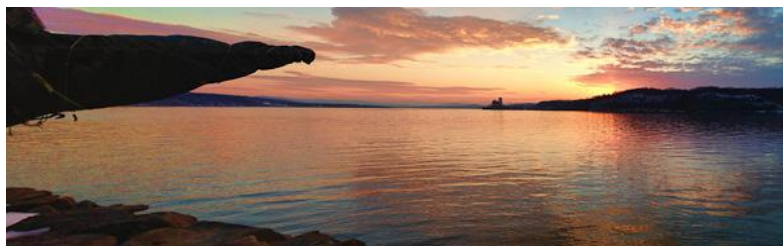
The party also serves as a winter gathering of crew, would be crew, and just plain interested and supporting folks. Thus, a pot luck.

The Department of Environmental Conservation is accepting comments on its revised proposal to amend 6 NYCRR Parts 52, 190, 550-556 and Subpart 750-1, and to add Part 560 and Subpart 750-3, to address high-volume hydraulic fracturing. 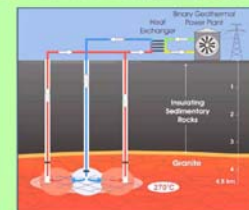

Vane Lashua has studied and written about the benefits and economics of geothermal systems. His most recent focus is on direct electricity generation systems. He is a member of the Geothermal Energy Association.
